The monthly performance of Bentley for 30 April was -1.823% compared with the ASX All Ordinaries Index of -0.600%. The year to date (YTD) performance of Bentley was +9.973% (with dividends added back) compared with the ASX All Ordinaries Index of +11.722% over the same period.
