CBG Fund Details as at 31 July 2016

As at 31 July 2016, Bentley had ~\$5.15 million (34.1% of its net assets) invested in the CBG Australian Equities Fund (Wholesale) (**CBG Fund**) (30 June 2016: ~\$4.85 million (31.2%)).

About the CBG Fund

The monthly performance of the CBG Fund for July 2016 was +6.8% (30 June 2016: -4.2%) compared with its benchmark performance (S&P/ASX 200 Accumulation Index) of +6.3% (30 June 2016: -2.5%).

The CBG Fund is a wholesale fund not open to retail investors. The objective of the fund is to outperform the S&P/ASX 200 Accumulation Index over the medium term. The Investment Manager is 'style neutral' and invests in growth stocks, value stocks, stocks with maintainable dividend yields and special situations.

CBG Fund details as at 31 July 2016:

- The equity weighting was 96.4% (30 June 2016: 93.7%);
- 84.8% of the equity portfolio is invested in companies contained within the S&P/ASX 200 Index (30 June 2016: 85.7%) with the balance of 15.2% invested in companies outside of the S&P/ASX 200 Index (30 June 2016: 14.3%); and
- The equity portfolio contained 45 holdings (30 June 2016: 45 holdings).
