## **Results of 2009 Annual General Meeting**

The Company announces the results of voting on the resolutions considered at the Annual General Meeting held earlier today.

Ordinary Resolutions 1 to 5 were **passed** on a poll. The proxy votes received also indicate majority support in favour of these resolutions.

Ordinary Resolution 6 (Election of Andrew Moffat as Director) was **not passed** on a poll. The proxy votes received also indicate a majority against this resolution.
